Job Title: Speech & Language Therapist – Band 5

Department: Speech & Language Therapy

Reports to: Head of Speech & Language Therapy

Job Purpose

The speech and language therapist is responsible for assessment, intervention and consultation, to facilitate development of students' communication and eating and drinking skills

Key Tasks

Team-working

To meet the needs of all students effectively by working in partnership with other disciplines, especially the Therapy and Psychology team.

- a) To demonstrate awareness of the roles of all other Therapy and Psychology disciplines
- b) To work together with other disciplines for the effective management of students wherever appropriate
- c) To direct the work of a Speech and Language Therapy technician where available in delivering therapy programmes for students on the post-holder's caseload
- d) To provide observation opportunities for Speech and Language Therapy trainees on Clinical Placement

Clinical Work – Complex special needs

To manage a delineated caseload of students with epilepsy and/or autism spectrum disorders together with other complex developmental or acquired needs attending the School and/or Further Education College through assessment, intervention and consultation.

- a) To provide a baseline assessment of each new student's communication and/or eating/drinking skills and the environment in which these skills are used
- b) To evaluate the impact of epilepsy or other complex neurological problems on a student's current communicative competence, taking into account variability and potential loss of skills
- c) To provide detailed recommendations which are suitable for incorporation into the student's education or care programmes
- d) To inform parents of the aims of regular therapy sessions
- e) To pass on skills in communication or eating and drinking issues related to a specific student
- f) To refer complex eating/drinking difficulties to a more senior SLT
- g) To seek advice on more complex AAC issues
- h) To identify other situations beyond the postholder's current clinical competence and refer on/seek advice as needed

Staff Training

To develop skills in training staff and carers on topics related to communication and/or eating and drinking by presenting workshops, induction or talks and to participate in external training as appropriate

- a) To participate in staff induction as required
- b) After initial probationary period, to run training sessions for internal staff in association with other SLTs on topics related to SLT area
- c) After initial period, to participate in external training courses in association with members of the SLT team or other staff at Young Epilepsy as appropriate

Special Responsibilities -
